## **Utility Account Tenant Agreement**

## **Water Restrictions for Upcoming Project**

- Wiley Springs rehabilitation will temporarily shut off primary water source
- Stored supply: 450,000 gallons

- Resolution 2025-4 Passed:
  - o Prohibits outdoor watering during shutoff
  - o Authorizes emergency water rate structure
  - Public hearing scheduled for September 8, 2025
  - Outreach includes town hall, mailers, ads, marquee, and door-to-door
