- a. Public Works no report
- b. Administrator/Deputy Clerk -Cally reported that the town received a grant from the Bureau of Reclamation in the amount of \$537,907 for the Wiley Spring rehabilitation. The town paid \$500 deductible for the snowplow accident. Cally gave the Pioneer Day Committee permission to close Highway 92 (they already had permission from CDOT) and we will be sending out letters to individuals on Cedar to not park on the street during the parade on June 8th. She reported that she finally got the NEU ARPA report submitted. We have had inquires to renting the building with alcohol. Bruce informed her that he will be working 4 10s Mon-Thurs. She said they had discussed it earlier but she's is of the opinion that he

should go salary. Al will be working 18 hours a week, Weds-Fri. Cirsa came to audit the office workspaces and made quite a few recommendations for desks and monitors for us to be sitting correctly in order to prevent injury. We will slowly be replacing some of the items he recommended.

- c. Board Members Tim Pobirk has been talking with Chris Roundy & Shawn Gardener regarding the mosquitos, he would like to have the dunks available to put in standing water. He will meet with them on the 29th of May and let the council know what they suggest. Cherri Olson reported that she did not make it to The Chamber meeting but will look at the minutes when they become available. Gill Saunders reported that he has not had a chance to meet with Bruce. Jim Crook reported that he has been working to keep the turkey vultures from roosting in the trees by hitting the trees with pvc pipe, lasers and air horn. There were about 27 and now only around 7. (Tim Pobirk offered to help also). Jeff Peed reported that the library has several programs coming up: Teens to help tech, murder mystery, older education EMS, book reading including adults to help get people off phones. Jessica Hart reported there has been some theft in the area, notable on Fir Street and the bar.
- d. Mayor's Report Chris Johnson reported that he and Cally went to a municipal quarterly meeting and met with Friends of Crawford Town Hall.
