## **ROLL CALL**

1. CALL THE MEETING TO ORDER 7:00 pm

- 2. APPROVAL OF THE AGENDA- Jeff Peed makes a motion to approve the agenda, Mike Tiedeman seconded the motion. Motion passed
- 3. CONSENT AGENDA

**Minutes –** Jeff Peed made corrections to the October 6 meeting minutes, under announcements, should read that the town received \$54K of 2022. Disbursements – Gill Saunders makes the motion to approve the minutes as corrected and the disbursements. John Paton seconds the motion. Motion passed

- 4. NON-AGENDA ITEMS Cally reports that after speaking with Commissioner Wendall Koontz regarding CTF funds from the County, he said they could give \$6500 to the Town, but all agreed that wasn't enough to help fund the project to restore the rock walls around the park. More Covid money is available if we spend the money we received last year, but we are having trouble spending the rest of that money. We have \$5100 left and that will pay for a new computer for Public Works and for the clerk. Elevate will install fiber at the water dispenser November 29 and then dispenser should be ready to go. Cally added that there is Opioid \$\$ that will be distributed but no one is really sure how that will all work, but she is working with the commissioners on this. She talked about a resolution that was written in 1985 regarding the fire department as the emergency response authority for hazardous substances. She asks if the council would like to re-write the resolution. It was decided that Cally would work with Kris Stewart and the fire department on this and then bring it back to the council.
- **5. ANNOUNCEMENTS** Mayor Gofforth announces the time change this week. Cally announce the Christmas Festival happening the week of Thanksgiving.
- 6. OLD BUSINESS\* None
- 7. **NEW BUSINESS\* Un-licensed Vehicle ordinance –** Wanda told the council that Lynn French had suggested that the town look into an ordinance for old unlicensed vehicles to keep people from having salvage yards. The council felt that our nuisance ordinance already

covers this. Gill Saunders added that they were elected to make things easier for people. Jim Crook added that he had things that are antiques on his property that can't be licensed without the cost being astronomical. He also reported a car that was parked on the street with Utah license plates should be tagged and didn't know why they hadn't been tagged. Cally explained that we (employees) don't go out looking for these things that we respond to the complaints of the citizens of the Town. She asked Jim where it was at, and he said that he didn't care that it was parked there that he didn't want to report it because he didn't care.

## 8. PUBLIC NON - AGENDA ITEMS

- a. **Public Works** Cally reports that the water is still doing good. Mike asked about the GPM and Cally responded that she didn't remember. Public Works installed new meter pits and had ordered cans.
- b. **Board Members** Jeff Peed announced that he had read the Tourism newsletter and he suggested that we investigate the Colorado Community Revitalization Grant. Cally added that might be how we could get more help with the restoration of the walls around the park. She will check into it!
- c. Clerk Cally reports that we have had 5 municipal code enforcement cases and they are going well. It seems that the town is being cleaned up. She added that we have 2 property liens for nonpayment for utilities filed with the County. We have had 5 in the last few years, and these are the last 2 so far. Cally also thanked Jeff Peed for helping with the Christmas lights.
- d. **Mayor's Report** -Next code enforcement will be held on November 16 at 9:00 am. Next Council Meeting will be held on November 17, 2021, we have nothing yet on the agenda. December 1 and the 15<sup>th</sup> will be the meetings in December, and on December 15<sup>th</sup> will be the public hearing for the budget.
